Agreement to Electronic Filing

This Agreement is entered into pursuant to the provision of the International Registration Plan and Neb. Rev. Stat. 60-356 and the International Fuel Tax Agreement and Neb. Rev. Stat. 66-1401 by the above named carrier for the purpose of authorizing the carrier to electronically file any renewals, returns, and applications as required for each program.

Carrier agrees as follows:

1. The signature of the carrier or its authorized agent affixed to this Agreement shall be deemed to appear on such electronically filed renewals, returns, and applications filed electronically pursuant to this Agreement are deemed by the carrier to be truthful, accurate and complete statements made under penalty of perjury.
2. Carrier shall be responsible for all costs associated with the carrier's transmission of such electronically filed renewals, returns and applications.
3. Upon discovery of any errors on any renewal, return, or application the carrier issues pursuant to this Agreement, the carrier shall contact the Motor Carrier Services Division immediately or not later than the next business day after the discovery to correct the error.
4. This Agreement may be amended at any time by the execution of a written addendum to this Agreement executed by Motor Carrier Services Division and the carrier.

- 5. The Motor Carrier Services Division or the carrier may terminate this Agreement at any time for any reason upon giving the other party ten (10) days written notice. The Motor Carrier Services Division shall immediately terminate the carrier's access to the computer system if the carrier consistently fails to file timely applications and returns or fails to make timely payments of any taxes and fees due, or if the carrier abuses or exceeds the authority granted under this Agreement, including but not limited to the use, disclosure, or sale of personal information received under this Agreement in a manner not authorized by the Nebraska Uniform Motor Vehicle Records Disclosure Act.

The carrier shall assume all risk of loss and hold the Motor Carrier Services Division, its employees, agents, assignees and legal representatives harmless from all liabilities, demands, claims, suits, losses, damages, causes of action, fines or judgements and all expenses incident thereto, for injuries to persons and for loss of, damage to, or destruction of property arising out of or in connection with the execution of the terms of the Agreement.
